I had wanted to join the CASA movement for years. I was fortunate enough to accomplish this goal on February 28, when I joined Blue Ridge CASA as CEO. Since coming on board, I have been consistently amazed and inspired by our volunteers' incredible and selfless work, our staff's talent and commitment, and our investors' generosity. Despite the challenges of COVID and rising costs, you chose to continue to support children in our community who have experienced abuse and neglect. Thank you.

It has been a year of transition for our organization: new leadership, new staff, and new goals. We set a new fundraising record at our Top Chef Harrisonburg event and had the COW-abunga Parade. We inducted a record number of new CASA volunteers.

We estimate there are over 300 local children in foster care. We believe every abused and neglected child in our community should have access to a Court Appointed Special Advocate. Often, a CASA is the only consistent person in a child's life while they are in foster care. This relationship is paramount, and the information the CASA can provide the judge is invaluable.

Serving each child is a lofty goal and will take time to achieve, but we are on our




I can't wait to see what we accomplish next year!

SUPPORTING FAMILIES

The families we serve are in turmoil and struggling with complex challenges. A CASA volunteer takes the time to understand their situation and build relationships with everyone involved. One of our CASAs did just that this year, and it changed the children's story.

The biological parents were battling addiction and homelessness and had ongoing conflict. The children blamed each other for disclosing these issues, which led to them being placed in foster care. Their CASA volunteer knew that building a relationship with their mom was the key to keeping the family connected, as she was the one who was focused on reunifying her family from the beginning. The CASA volunteer joined the family and the social services worker weekly for hour-long supervised visits, held their father accountable for attending substance abuse treatment, and encouraged their mom when she felt lost and at the end of her rope.

It's been a long road, but the family has been reunited. Dad is sober, and the family has stable housing. Their CASA volunteer was a critical part of their success. CASAs make a difference!

ENHANCED ADVOCACY A TEAM APPROACH

A Rockbridge County couple chose to provide advocacy as a team, which has led to some outstanding results. With the demands of their jobs, family, and other volunteer commitments becoming Court Appointed Special Advocates was an enormous undertaking. They discovered sharing the workload and playing to their strengths made it possible. Their different interests, hobbies, and life experiences have positively impacted their ability to connect with those involved in their case. Aside from the behind-the-scenes work, joining forces while visiting with their CASA kids provided unique advantages. One could focus directly on the children while the other could connect with the caregiver. The team approach was a valuable experience for both volunteers and provided outstanding advocacy for the children.
